On February 9, 2023, the Acquiror, disposed of 2,990,000 shares (the “Shares”) of the Issuer at a price of Cdn \$0.065 per Share through a public sale (the “Transaction”) and as a result, the acquiror now holds 20.62% of the issuer’s issued and outstanding.

Prior to the disposition of the Shares, the Acquiror and Goldeneye Capital Ltd. (“Goldeneye”), a company controlled by the Acquiror, beneficially owned and controlled 23,863,332 Common Shares, representing 23.57% of the issued and outstanding Common Shares. As a result of the disposition of the Shares, the Acquiror and Goldeneye now beneficially own and control an

aggregate of 20,873,332 Common Shares representing 20.62% of the issued and outstanding Common Shares.
