DESCRIPTION OF BUSINESS

Rain City Resources Inc. ("the Company") was incorporated on June 23, 2015 under the laws of British Columbia. The address of the Company's corporate office and its principal place of business is Suite 3043-595 Burrard Street, Vancouver, British Columbia, Canada.

The Company's principal business activities include the acquisition and exploration of mineral property assets. As at March 31, 2022, the Company had not yet determined whether the Company's mineral property asset contains ore reserves that are economically recoverable. The recoverability of amount shown for exploration and evaluation asset is dependent upon the discovery of economically recoverable reserves, confirmation of the Company's interest in the underlying mineral claims, the ability of the Company to obtain the necessary financing to complete the development of and the future profitable production from the property or realizing proceeds from its disposition. The outcome of these matters cannot be predicted at this time and the uncertainties cast significant doubt upon the Company's ability to continue as a going concern.

In March 2020, The World Health Organization declared COVID-19 a global pandemic. This contagious disease outbreak and any related adverse public health developments, has adversely affected workforces, economies, and financial markets globally, leading to an economic downturn. The pandemic could continue to have negative impact on the stock market, including trading prices of the Company's shares and its ability to raise new capital. At this point, the impact on the Company has been minimal. The Company continues to monitor the situation and is taking all necessary precautions in order to follow rules and best practices as set out by the federal and provincial governments.

Northern Champion Project

Pursuant to an option agreement (the "Agreement") dated October 25, 2016, the Company was granted an option to acquire a 100% undivided interest in the Northern Champion Project (the "Property") located near Champion Creek, south-west of Tulameen, Princeton area British Columbia.

In accordance with the Agreement, the Company has the option to acquire a 100% undivided interest in the Property by issuing a total of 700,000 common shares of the Company to the Optionors, making cash payments totaling \$130,000, and incurring a total of \$650,000 in exploration expenditures as follows:

The Optionors will retain a 3% Net Smelter Returns royalty on the Property. The Company has the right to purchase the first 1% of the royalty for \$750,000 and the remaining 2% for \$1,000,000 at any time prior to the commencement of commercial production. As at March 31, 2022, the Company had incurred some exploration expenditure that were due on or before second anniversary of the listing on April 25, 2019, but not the entire \$100,000.

On January 26, 2021, the Company had paid the \$10,000 in cash and issued 100,000 common shares that were due on or before the first anniversary of the listing on April 25, 2019.

On May 21, 2021, the Company had issued 100,000 common shares that was due on or before the second anniversary of the listing on April 25, 2019.

On May 26, 2021, the Company had paid the \$20,000 in cash that was due on or before the second anniversary of the listing on April 25, 2019.

On September 21, 2021, the Company had received a letter indicated the work commitments were extended until Jan 25, 2022.

During the year ended September 30, 2021 the Company received \$19,310 in respect of the BC Mining tax credit (2020: \$Nil).

On May 18, 2022, the company had received a further extension to the option agreement until September 30,2022.

On May 24, 2022 the company had issued 100,000 common shares that was due on or before the second anniversary of the listing on April 25, 2019.

Bro property

Pursuant to an agreement dated April 21, 2021, the Company acquired an option to purchase a 100% interest in four mineral claims located in Yukon, collectively known as the Bro Property for an aggregate consideration of CAD \$3,000,000. The Optionors will retain a 3% Net Smelter Returns royalty on the Property.

Payments in cash or stock to comprise a total CAD\$2,500,000 as to the following:

- CAD\$500,000 payable within 30 days of signing (paid)
- CAD\$500,000 payable on the first anniversary (issued on May 24, 2022)
- CAD\$500,000 payable on the second anniversary

On April 26, 2021, the Company had paid the \$500,000 in cash that was due on within 30 days signing of the agreement.

On May 24, 2022, the Company had issued 10,000,000 common shares that was due on or before the first anniversary of the property purchase and sale agreement on April 21, 2021.

OPERATIONS

The year ended September 30, 2021

For the year ended September 30, 2021 the Company reported a net loss of \$436,859 compared to a loss of \$190,187 in prior year. Contributors to the annually net loss include (i) \$3,013 attributable to interest income (ii) a \$127,553 realized loss on sales of marketable securities and (iii) a \$4,554 unrealized gain on marketable securities.

Expenses for the year ended September 30, 2021 include \$23,703 on accounting fees (2020 \$59,732), \$15,847 (2020 - \$20,552) on rent, \$5,153 (2020 - \$nil) on advertising, \$2,945 (2020 - \$324) on bank charges, \$185,492 (2020 - \$nil) on professional fees, \$13,656 (2020 - \$20,250) on legal fees, \$56,000 (2020 - \$20,500) on management fees, \$69 (2020 - \$3,612) on office expenses, \$12,121 (2020 - \$14,976) on transfer agent and filing fees, \$1,887 (2020 - \$13,361) on travel and promotion.

For the three months period ended March 31, 2022

During the period ended March 31, 2022, the Company reported a net loss of \$242,092 compared to a net profit of \$104,286 for the period ended March 31, 2021. Included in the determination of operating loss was \$25,800 (2021 - \$8,200) for accounting fees, \$256 (2021- \$159) bank charges, \$426 (2021 - \$Nil) for legal fees, \$Nil (2021 - \$8,000) for management fees, \$17,414 (2021- \$23,039) for professional fees, \$300 (2021 - \$Nil) for promotion, \$7,563 (2021 - \$3,082) for transfer agent and filing fees.

Realized losses on sale of marketable securities were \$8,175 for the period ended March 31, 2022 compared to realized gain \$39,453 for the 2021 comparative period. The losses were realized from the sale of the common shares of several publicly traded mining exploration companies held for investment to fund the Company's operations.

Unrealized loss on short-term investments were \$182,158 for the period ended March 31, 2022 compared to \$106,469 unrealized gain for the 2021 comparative period. The amount represents unrealized losses from market price fluctuations of the common shares of publicly traded mining exploration companies held for investment recorded at fair value using quoted market prices as at March 31, 2022.

Interest income was \$Nil for the period ended March 31, 2022 compared to \$844 for the 2021 comparative period.

LIQUIDITY AND CAPITAL RESOURCES

The Company's financial statements have been prepared on a going concern basis, which contemplates that the Company will continue in operation for the foreseeable future and will be able to realize its assets and discharge its liabilities in the normal course of business. The Company's ability to continue as a going concern is dependent on the ability of the Company to raise equity financing and attainment of profitable operations. Management has been successful in raising equity financing in the past. However, there is no assurance that it will be able to do so in the future.

Factors that could impact on the Company's liquidity are monitored regularly and include market changes and economic downturns that affect the market price of the Company's trading securities for the purposes of raising financing. The current state of equity markets presents a challenge to raise financing and Management believes that this condition will continue over the next twelve months.

The Company's cash and cash equivalents at March 31, 2022 were \$9,961 compared to \$76 at March 31, 2021. The Company had a working capital surplus of \$299,866 (2021 - \$203,181) at March 31, 2022. Based on the above financial condition at March 31, 2022, Management believes that the Company has the financial resources to meet its financial obligations as they become payable in the current fiscal period.

OFF-BALANCE SHEET ARRANGEMENTS

The Company has not entered into any off-balance sheet arrangements.

TRANSACTIONS WITH RELATED PARTIES

Parties are considered to be related if one party has the ability, directly or indirectly, to control the other party or exercise significant influence over the other party in making financial and operating decisions. Related parties may be individuals or corporate entities. A transaction is considered to be a related party transaction when there is a transfer of resources or obligations between related parties.

Management fees and share-based payments were incurred from a director and a company owned by a director of the Company. Key management includes directors and key officers of the Company, including the President, Chief Executive Officer ("CEO") and Chief Financial Officer ("CFO").

During the period ended March 31, 2022, the Company incurred \$13,500 (2021 -\$Nil) in consulting fee to a director. As at March 31, 2022, an amount of \$16,000 (2021 - \$Nil) included in accounts payable was due to director of the Company.

During the period ended March 31, 2022, the Company incurred \$18,626 (2021 -\$44,747) in fees to a company controlled by the CFO. As at March 31, 2022, an amount of \$37,109 (2021 - \$15,750) is included in accounts payable was due to company controlled by the CFO of the Company.

COMMITMENTS

The Company is committed to certain cash payments, share issuance and exploration expenditures in connection with the acquisition of its mineral property claims.

APPLICATION OF NEW AND REVISED INTERNATIONAL FINANCIAL REPORTING NEW ACCOUNTING STANDARDS ISSUED AND EFFECTIVE

Accounting standards and amendments issued but not yet adopted

A number of new standards and amendments to existing standards have been issued by the IASB that are mandatory for accounting periods beginning on or after June 1, 2021, or later periods. The Company has not early adopted these new standards in preparing these condensed consolidated financial statements. There new standards are either not applicable or are not expected to have a significant impact on the Company's condensed consolidated financial statements

CRITICAL ACCOUNTING POLICIES

The preparation of the financial statements in accordance with IFRS requires the use of certain critical accounting estimates and judgments. It also requires management to exercise judgment in applying the Company's accounting policies. These judgments and estimates are based on management's best knowledge of the relevant facts and circumstances taking into account previous experience, but actual results may differ from amounts included in the financial statements. The critical accounting estimates and judgments used by the Company are described in Note 3 of the Company's financial statements for the period ended March 31, 2022.

FINANCIAL INSTRUMENTS AND FINANCIAL RISK

International Financial Reporting Standards 7, Financial Instruments: Disclosures, establishes a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy has the following levels:

Level 1 - quoted prices (unadjusted) in active markets for identical assets or liabilities;

Level 2 - inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices); and

Level 3 - inputs for the asset or liability that are not based on observable market data (unobservable inputs).

Fair Value of Financial Instruments

The Company's financial assets include cash and are classified as Level 1. The carrying value of these instruments approximates their fair values due to the relatively short periods of maturity of these instruments.

Financial risk management objectives and policies

The Company's financial instruments include cash and marketable securities. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. Management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

(i) Currency risk

The Company's expenses are denominated in Canadian dollars. The Company's corporate office is based in Canada and current exposure to exchange rate fluctuations is minimal.

The Company does not have any significant foreign currency denominated monetary liabilities. The principal business of the Company is the identification and evaluation of assets or a business and once identified or evaluated, to negotiate an acquisition or participation in a business subject to receipt of shareholder approval and acceptance by regulatory authorities.

(ii) Interest rate risk

The Company is exposed to interest rate risk on the variable rate of interest earned on bank deposits. The fair value interest rate risk on bank deposits is insignificant as the deposits are short-term.

The Company has not entered into any derivative instruments to manage interest rate fluctuations.

(iii) Credit risk

Credit risk is the risk of loss associated with the counterparty's inability to fulfill its payment obligations. Financial instruments that potentially subject the Company to concentrations of credit risks consist principally of cash. To minimize the credit risk, the Company places these instruments with a high quality financial institution.

(iv) Liquidity risk

In the management of liquidity risk of the Company, the Company maintains a balance between continuity of funding and the flexibility through the use of borrowings. Management closely monitors the liquidity position and expects to have adequate sources of funding to finance the Company's projects and operations.

SHARE CAPITAL
