An aggregate of 300,000 common shares of GLM were purchased on the CSE on September 11, 2019. In addition, on September 12, 2019, the acquiror was granted 200,000 options at an exercise price of \$0.11 exercisable for a period of 3 years from the date of grant.

An aggregate of 300,000 common shares of GLM were purchased, collectively representing approximately 2.4% of the issued and outstanding shares of GLM.

Following the purchases of shares, the acquiror has ownership or control over 2,130,000 common shares of GLM representing approximately 17.2% of the issued and outstanding shares (or 2,330,000 common shares of GLM representing approximately 18.6% of the issued and outstanding shares, assuming exercise of all options held by the acquiror).
