On March 5, 2021, 2176423 Ontario acquired (the "Acquisition") ownership of 4,444,444 Units of the Corporation at a price of \$0.45 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.60 per Share until two years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
