On April 30, 2021, Eric Sprott, through 2176423 Ontario, a corporation which is beneficially owned by him, acquired (the “**Acquisition**”) ownership of 4,000,000 Units and through Lariscan Enterprises Ltd., a corporation which is controlled by him, acquired ownership of 4,000,000 Units of the Corporation at a price of \$0.50 per Unit. Each Warrant entitles the holder thereof to acquire one Share at a price of \$0.67 per Share for a period of 24 months from issuance. The Units were purchased from the Corporation on a private placement basis.

Lariscan Enterprises Ltd.

After giving effect to the acquisition, Mr. Sprott beneficially owns and controls 8,000,000 Shares and 8,000,000 Warrants, representing approximately 9.6% of the issued and outstanding Shares on a non-diluted basis, and approximately 17.5% on a partially diluted basis assuming exercise of the Warrants.

The Units were acquired for investment purposes. Mr. Spratt has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Spratt currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Spratt may develop such plans or intentions in the future.
