On April 30, 2023, a total of 8,000,000 Warrants with an exercise price of \$0.67 per common share of the Corporation ("Share"), 4,000,000 Warrants held by 2176423 Ontario (a corporation beneficially owned by Eric Sprott) and 4,000,000 Warrants (held by Lariscan Enterprises Ltd., a corporation which is controlled by him), expired unexercised, resulting in Mr. Sprott's beneficial ownership of the Corporation to decrease by approximately 4.2 % on a partially diluted basis since the date of the last early warning report.

Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
