**Item 2 Description of the Transaction**

The Parties completed of a statutory arrangement under a plan of arrangement (the “**Arrangement**”) on February 22, 2019 (the “**Effective Date**”). As a result of completing the Arrangement, Plank became a reporting issuer in the provinces of British Columbia and Alberta.

Completion of the Arrangement, as set forth in the arrangement agreement and plan of arrangement dated August 28, 2018 (the “**Arrangement Agreement**”) entered into between the Parties, was approved by the shareholders of MOBIO on December 31, 2018 and by the Supreme Court of British Columbia on January 8, 2019, in accordance with Part 9 of the *Business Corporations Act* (British Columbia).

February 22, 2019.

No party ceased to be a reporting issuer subsequent to the completion of the Arrangement.

Upon completion of the Arrangement, MOBIO continues to be a listed issuer on the TSX Venture Exchange and a reporting issuer in the provinces of British Columbia and Alberta and Plank became a reporting issuer in British Columbia and Alberta.
