In connection with the transaction, a total of 26,904,000 common shares in the capital of the Issuer (each a "Mongoose Share") were issued to holders of Spark shares on a one for one basis.

The Acquiror, as a holder of common shares of Spark, received 13,006,993 Mongoose Shares in connection with the transaction, representing approximately 40.7% of the issued and outstanding Mongoose Shares.
