Common shares of Vinza Capital Management Inc. (each, a "**Share**").

The issuer is Vinza Capital Management Inc. (the "**Issuer**"), with a head office at 328 - 20th Avenue West Vancouver, BC V5Y 2C6.

The transaction that triggered the requirement to file this report was the acquisition of Shares as part of a private placement, pursuant to which the Issuer issued 6,250,000 Shares at a price of \$0.01 per Share for proceeds of \$62,500, which closed on September 27, 2019 (the "**Private Placement**"). The transaction did not take place on a market.

The Acquiror purchased 1,500,000 Shares as part of the Private Placement.
