This report relates to the sale of 1,350,000 common shares of Vinza Capital Management Inc. (each, a "**Share**").

The issuer is Vinza Capital Management Inc. (the "**Issuer**"), with a head office at 328 - 20th Avenue West, Vancouver, BC V5Y 2C6.

**1.2 State the name of the market in which the transaction or other occurrence that triggered the requirement to file this report took place.**

As disclosed in the Issuer's press release dated September 21, 2020, the transaction that triggered the requirement to file this report was the sale of 1,350,000 Shares to Eric Boehnke (the "**Disposition**"). The Issuer is not listed on a market and the Disposition was a private transaction.

Paul Visosky, indirectly through Casa Stilts Law Corp., a controlled company, of 1000 - 595 Howe Street, Vancouver, BC V6C 2T5 (the "**Acquiror**").

**2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

The Acquiror sold 1,350,000 Shares in a private transaction that was effective September 21, 2020.

The Acquiror disposed of 1,350,000 Shares representing approximately 21.6% of the issued and outstanding Shares of the Issuer, with the result that the Acquiror now owns

150,000 Shares of the Issuer representing approximately 2.4% of the Issuer's 6,250,469 issued and outstanding Shares.

The Acquiror indirectly beneficially owned 1,500,000 Shares immediately before the completion of the Disposition.

Immediately after the completion of the Disposition, the Acquiror beneficially owned and controlled a total of 150,000 Shares, representing approximately 2.4% of the Issuer's issued and outstanding Shares.
