The issuer is Vinza Capital Management Inc. (the "**Issuer**"), with a head office at 1700 – 1066 West Hastings Street, Vancouver, BC V6E 3X1.

As disclosed in the Issuer's press release dated January 25, 2021, the transaction that triggered the requirement to file this report was the purchase of 1,800,000 shares that were included in the aggregate purchase and sale of 4,050,000 shares by several parties. The Issuer is not listed on a market and the purchase was a private transaction.
