Common shares of InnoCan Pharma Corporation (the “**Issuer**”), head office located at 1015, 926 - 5 Avenue SW Calgary, Alberta T2P 0N7.

This report is filed in respect of the acquisition of common shares of the Issuer in connection with the exercise of warrants of the Issuer held by Tamar Innovest Limited (the “**Exercise**”).

The acquiror is Tamar Innovest Limited (“**Tamar**”), head office located at 3 Bedlam Court, Office Suite 3 Montarik Building, Gibraltar GX11 1AA.

On February 22, 2021, upon completion of the Exercise, Tamar acquired 10,321,282 common shares of the Issuer.

Upon completion of the Exercise, Tamar acquired ownership and control of an aggregate of 15,981,916 common shares in the capital of the Issuer. The common shares of the Issuer acquired by Tamar upon completion of the Exercise represents approximately 4.9% of the Issuer’s current issued and outstanding common shares.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.

Tamar acquired ownership and control of the securities that are the subject of this report.

Prior to completion of the Exercise, Tamar had ownership and control of 34,385,706 common shares of the Issuer, representing approximately 17.2% of the issued and outstanding common shares of the Issuer. Following completion of the Exercise, Tamar has ownership and control of 44,706,988 common shares of the Issuer, representing approximately 21.2% of the issued and outstanding common shares of the Issuer.

Tamar has ownership and control over 44,706,988 common shares of the Issuer, representing approximately 21.2% of the issued and outstanding common shares of the Issuer.

The common shares were acquired upon the cashless exercise of common share purchase warrants of the Issuer held by Tamar. 9,264,480 shares acquired had an exercise price of US\$0.1252 (CAD\$0.1579) and 1,056,802 of the shares acquired had an exercise price of US\$0.175 (CAD\$0.22), for total deemed consideration of US\$1,344,853.25 (CAD\$1,696,263.40).
