Volatus Capital Corp. Completes Initial Public Offering

Vancouver, British Columbia, August 29, 2019: Volatus Capital Corp. (the "Company" or "Volatus") (CSE: VC) is pleased to announce that on August 29, 2019, it completed its initial public offering (the "IPO") of 4,025,000 common shares in its capital (each a "Share"), 525,000 of which were sold pursuant to an over-allotment option, at a price of \$0.10 per Share for gross proceeds of \$402,500. The net proceeds from the IPO will be used for working capital and to carry out exploration of the Company's Sunset Copper Star Property located approximately 19 kilometres northwest of the city of Campbell River on Vancouver Island, British Columbia, in the Nanaimo Mining Division.

Haywood Securities Inc. acted as agent (the "Agent") for the IPO. The Agent received a cash commission equal to 10% of the gross proceeds of the IPO and a corporate finance fee of \$40,000, of which \$30,000 was paid in cash and \$10,000 in Shares. Additionally, the Company granted the Agent and its selling group compensation options entitling the holder to purchase in aggregate 402,500 Shares at a price of \$0.10 per Share, exercisable on or before August 29, 2021.

The Shares were approved for listing on the Canadian Securities Exchange on August 26, 2019 and are expected to begin trading on August 30, 2019 under the symbol "VC".

The offered securities have not been and will not be registered under the United States *Securities Act of 1933*, as amended (the "U.S. Securities Act"), or any applicable state securities laws and may not be offered or sold in the United States or to "U.S. persons", as such term is defined in Regulation S under the U.S. Securities Act, absent such registration or an applicable exemption from such registration requirements. This news release shall not constitute an offer to sell or the solicitation of an offer to buy the offered securities in any jurisdiction.

Volatus is engaged in the business of mineral exploration and the acquisition of mineral property assets in Canada. Its objective is to locate and develop economic precious and base metal properties of merit and to conduct its exploration program on the Sunset Copper Star Property. The Sunset Copper Star Property consists of two (2) contiguous mineral tenures covering an area of 1,138.15 hectares, located approximately 19 kilometres northwest of the city of Campbell River in the Nanaimo Mining Division, British Columbia.
