On May 29, 2020, the Issuer issued a total of 2,230,000 Common Shares from treasury by way of a non-brokered private placement. The dilution represents a decrease of 2.57% in the Acquiror’s securityholding percentage in the issued and outstanding Common Shares of the Issuer based on a total of 22,395,167 Common Shares outstanding as of May 29, 2020.

Following the May 29, 2020 Transaction, the Acquiror owned and controlled, directly and indirectly, 5,195,000 Common Shares of the Issuer representing 23.20% of the then issued and outstanding Common Shares of the Issuer based on a total of 22,395,167 Common Shares outstanding as of May 29, 2020.
