The transaction that triggered the requirement to file this report was an issuance from treasury by the Issuer and the acquisition of Common Shares of the Issuer by way of private placement.

2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

On June 3, 2020, the Acquiror acquired, indirectly through Exploits, ownership and control of 500,000 Common Shares of the Issuer at a price of \$0.15 per Common Share for total consideration of \$75,000 by way of a non-brokered private placement by the Issuer.

On June 5, 2020, the Issuer issued a total of 3,200,000 Common Shares from treasury that diluted the Acquiror's securityholdings.

On June 5, 2020, the Acquiror acquired ownership and control of 3,750,000 Common Shares of the Issuer at a deemed price of \$0.15 per Common Share for total consideration of \$562,500 by way of a mineral property transaction with the Issuer.

The acquisitions and dilution represent an increase of 8.99% in the Acquiror's securityholding percentage in the issued and outstanding Common Shares of the Issuer based on a total of 29,895,167 Common Shares outstanding as of June 5, 2020.

John Michael William Collins ("**Collins**"), President and Chief Executive Officer of both the Issuer and the Acquiror.

3. Interest in Securities of the Reporting Issuer

On June 3, 2020, the Acquiror acquired, indirectly through Exploits, ownership and control of 500,000 Common Shares of the Issuer.

On June 5, 2020, the Issuer issued a total of 3,200,000 Common Shares from treasury that diluted the Acquiror's securityholdings.

On June 5, 2020, the Acquiror acquired ownership and control of 3,750,000 Common Shares of the Issuer.

These transactions represent a net increase of 8.99% in the Acquiror's securityholding percentage in the issued and outstanding Common Shares of the Issuer, or a net increase of 8.41% in the Acquiror's securityholding percentage of the deemed outstanding shares of the Issuer including the 500,000 Warrants held by the Acquiror on an exercised basis.

The Issuer issued Common Shares from treasury and the Acquiror acquired ownership and control over Common Shares, with a net increase in the Acquiror's security holdings that triggered the requirement to file this report.

Prior to the Transaction, the Acquiror owned and controlled 4,666,667 Common Shares of the Issuer representing 20.84% of the then issued and outstanding Common Shares of the Issuer based on a total of 22,395,167 Common Shares outstanding as of May 29, 2020; or 5,166,667 Common Shares of the Issuer representing 22.57% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.

Subsequent to the Transaction, the Acquiror owned and controlled 8,916,667 Common Shares of the Issuer representing 29.83% of the then issued and outstanding Common Shares of the Issuer based on a total of 29,895,167 Common Shares outstanding as of June 5, 2020; or 9,416,667 Common Shares of the Issuer representing 30.98% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.

Prior to the Transaction, the Acquiror together with Collins owned and controlled 5,746,667 Common Shares of the Issuer representing 25.66% of the then issued and outstanding Common Shares of the Issuer based on a total of 22,395,167 Common Shares outstanding as of May 29, 2020; or 6,246,667 Common Shares of the Issuer representing 27.28% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.

Subsequent to the Transaction, the Acquiror together with Collins owned and controlled 9,996,667 Common Shares of the Issuer representing 33.44% of the then issued and outstanding Common Shares of the Issuer based on a total of 29,895,167 Common Shares outstanding as of June 5, 2020; or 10,496,667 Common Shares of the Issuer representing 34.53% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.

(b) the Acquiror, either alone or together with any joint actors, has ownership but control is held by persons or companies other than the Acquiror or any joint actor, and
