On August 25, 2021, the Acquiror acquired 6,250,000 Common Shares at a deemed price of \$0.12 per Common Share for total investment of \$750,000 by way of a private placement.

Emma Fairhurst ("Fairhurst"), Chairperson, interim Chief Executive Officer, Director and 10% holder of the Acquiror.

On August 25, 2021, the Acquiror acquired 6,250,000 Common Shares of the Issuer.

This transaction represents an increase of 12.34% in the Acquiror's securityholding percentage in the issued and outstanding Common Shares of the Issuer, or an increase of 13.20% in the Acquiror's securityholding percentage of the deemed outstanding shares of the Issuer assuming exercise of the 500,000 warrants held by the Acquiror.

The Acquiror acquired the securities that triggered the requirement to file the report.

Subsequent to the Transaction, the Acquiror owned and controlled 16,965,667 Common Shares of the Issuer representing 33.50% of the then issued and outstanding Common Shares of the Issuer based on a total of 50,644,407 Common Shares outstanding as of August 25, 2021; or 17,465,667 Common Shares of the Issuer representing 34.15% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.

Prior to the Transaction, the Acquiror together with Fairhurst owned and controlled 18,710,667 Common Shares of the Issuer representing 42.15% of the then issued and outstanding Common Shares of the Issuer based on a total of 44,394,407 Common Shares outstanding as of August 24, 2021; or 19,210,667 Common Shares of the Issuer representing 42.79% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.

Subsequent to the Transaction, the Acquiror together with Fairhurst owned and controlled 24,960,667 Common Shares of the Issuer representing 49.29% of the then issued and outstanding Common Shares of the Issuer based on a total of 50,644,407 Common Shares outstanding as of August 25, 2021; or 25,460,667 Common Shares of the Issuer representing 49.79% of the outstanding shares assuming exercise of the 500,000 warrants held by the Acquiror.
