On March 9, 2022 the Acquiror acquired 12,200,000 units at a price of \$0.05 per unit for total investment of \$610,000 by way of a private placement.

On March 9, 2022, the Acquiror acquired 12,200,000 units of the Issuer.

This transaction represents an increase of 17% in the Acquiror’s securityholding percentage in the issued and outstanding Common Shares of the Issuer, or an increase of 29.06% in the Acquiror’s securityholding percentage of the deemed outstanding shares of the Issuer assuming exercise of the warrants held by the Acquiror.

Subsequent to the transaction, the Acquiror owned or controlled 37,165,667 Common Shares of the Issuer representing 51.79% of the issued and outstanding Common Shares based on a total of 71,769,407 Common Shares outstanding as of March 9, 2022; or 57,065,667 Common Shares of the Issuer representing 62.26% of the outstanding shares assuming exercise of the 19,900,000 warrants held by the Acquiror.
