On March 17, 2023 the Acquiror sold 1,000,000 Common Shares of the Issuer at a price of \$0.03 per Common Share for a total sale price of \$30,000.

On March 17, 2023, the Acquiror sold 1,000,000 Common Shares of the Issuer.

This transaction represents a decrease of 2.8% in the Acquiror’s securityholding percentage in the issued and outstanding Common Shares of the Issuer, or a decrease of 2.46% in the Acquiror’s securityholding percentage of the deemed outstanding shares of the Issuer assuming exercise of the warrants held by the Acquiror.

Subsequent to the transaction, the Acquiror owned or controlled 8,191,416 Common Shares and 4,850,000 warrants of the Issuer representing 22.92% of the issued and outstanding Common Shares based on a total of 35,748,604 Common Shares outstanding as of March 17, 2023; or 13,041,416 Common Shares of the Issuer representing 32.13% of the outstanding shares assuming exercise of the 4,850,000 warrants held by the Acquiror.
