On September 6, 2022, the Acquiror acquired 8,000,000 Units at a price of \$0.05 per Unit in a private placement (the "**Private Placement**") for a total investment of \$400,000. Each Unit is comprised of one common share ("**Common Share**") and one Common Share purchase warrant ("**Warrant**"). Each Warrant entitles the holder to acquire one Common Share of the Company for a period of five years from the closing of the Private Placement at an exercise price of \$0.06 per share.

On September 6, 2022, the Acquiror acquired 8,000,000 Common Shares and 8,000,000 Warrants of the Issuer (the "**Transaction**"). Immediately prior to the Transaction, the Acquiror did not own or have control over any securities of the Issuer. As a result of the Transaction, the Acquiror owned and/or had control over 8,000,000 Common Shares of the Issuer, representing approximately 24.65% of the undiluted issued and outstanding shares of the Issuer, based on a total 32,448,604 Common Shares as at September 5, 2022. Should the Acquiror exercise all of the Warrants, the Acquiror would hold 16,000,000 Common Shares, representing approximately 39.55% of the issued and outstanding Common Shares.

Should the Acquiror exercise all of the Warrants, the Acquiror would hold 16,000,000 Common Shares, representing approximately 39.55% of the issued and outstanding Common Shares (on a partially diluted basis) based on a total of 40,448,604 Common Shares.
