The transaction that triggered the requirement to file the report was carried out in a private transaction and not through any market.

#### **Item 2 – Identity of the Acquiror**

Newpath Resources Inc. (formerly, Ready Set Gold Corp.) (the “**Acquiror**”) with an address of #220-333 Terminal Avenue, Vancouver, BC V6A 4C1.

**2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

On September 6, 2022, the Acquiror acquired 8,000,000 Units at a price of \$0.05 per Unit in a private placement (the “**Private Placement**”) for a total investment of \$400,000. Each Unit is comprised of one common share (“**Common Share**”) and one Common Share purchase warrant (“**Warrant**”). Each Warrant entitles the holder to acquire one Common Share of the Company for a period of five years from the closing of the Private Placement at an exercise price of \$0.06 per share.

#### **Item 3 – Interest in Securities of the Reporting Issuer**

**3.1 State the designation and number or principal amount of securities acquired or disposed of that triggered the requirement to file this report and the change in the acquiror’s security holding percentage in the class of securities.**

On September 6, 2022, the Acquiror acquired 8,000,000 Common Shares and 8,000,000 Warrants of the Issuer (the “**Transaction**”). Immediately prior to the Transaction, the Acquiror did not own or have control over any securities of the Issuer. As a result of the Transaction, the Acquiror owned and/or had control over 8,000,000 Common Shares of the Issuer, representing approximately 24.65% of the undiluted issued and outstanding shares of the Issuer, based on a total 32,448,604 Common Shares as at September 5, 2022. Should the Acquiror exercise all of the Warrants, the Acquiror would hold 16,000,000 Common Shares, representing approximately 39.55% of the issued and outstanding Common Shares (on a partially diluted basis) based on a total of 40,448,604 Common Shares.

**3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.**

The Acquiror acquired the securities that triggered the requirement to file this report. See Item 2.2.

Prior to the Transaction, the Acquiror did not own or control any securities of the Issuer, representing 0% of the issued and outstanding Common Shares of the Issuer based on a total of 18,098,604 Common Shares as of September 5, 2022.

Subsequent to the Transaction, the Acquiror controlled 8,000,000 Common Shares of the Issuer representing approximately 24.65% of the issued and outstanding Common Shares of the Issuer based on a total of 32,448,604 Common Shares as of September 5, 2022.

Should the Acquiror exercise all of the Warrants, the Acquiror would hold 16,000,000 Common Shares, representing approximately 39.55% of the issued and outstanding Common Shares (on a partially diluted basis) based on a total of 40,448,604 Common Shares.
