In connection with the Transaction, the Issuer issued an aggregate of 7,198,855 common shares in the capital of the Issuer to the Vendors with a value of \$1.82 per common share (based on the closing price of the Issuer's common shares on April 7, 2022) and paid to the Vendors US\$50,000. The Apex Property remains subject to a 3% net smelter return royalty in favour of the Vendors.
