Common shares (the "Shares") of High Point Exploration Inc. (the "Issuer"), having its head office at Suite 1080, 789 West Pender Street, Vancouver, British Columbia, Canada V6C 1H2.

The transaction that triggered the filing of this report was the non-brokered private placement of 25,000,000 units of the Issuer, each consisting of one Share and one Share purchase warrant, completed by the Issuer on July 31, 2020 (the "Private Placement"). Each unit was issued at a price of \$0.02.

The Private Placement resulted in the percentage of the Shares controlled by the Acquiror to decrease below 10%.

The Issuer's Shares trade on the Canadian Securities Exchange (the "CSE").

Prior to the Private Placement, the Acquiror controlled 2,121,891 Shares of the Issuer representing 26.66% of the Issuer's issued and outstanding Shares on a non-diluted basis and on a fully diluted basis.

The Acquiror purchased 150,000 units of the Issuer pursuant to the Private Placement. Each unit consists of one Share and one Share purchase warrant.

After the Private Placement, the Acquiror controlled and aggregate of 2,271,891 Shares representing 6.89% of the Issuer's issued and outstanding Shares on a non-diluted basis and 4.18% of the Issuer's issued and outstanding Shares on a fully-diluted basis.

The Private Placement resulted in the Acquiror having control of less than 10% of the issued and outstanding Shares of the Issuer. The Acquiror acquired ownership over 150,000 units pursuant to the Private Placement.
