After the Private Placement, the Acquiror controlled and aggregate of 2,272,271 Shares representing 6.89% of the Issuer's issued and outstanding Shares on a non-diluted basis and 4.18% of the Issuer's issued and outstanding Shares on a fully-diluted basis.
