The requirement to file this report was triggered by the closing of the Private Placement on January 21, 2022, in which Crescat, an investment manager with discretionary authority operating in the United States, acquired 4,458,334 units of the Issuer (the “**Units**”) at a price of \$0.24 per Unit. Each Unit was comprised of one common share of the Issuer (each, a “**Common Share**”) and one common share purchase warrant of the Issuer (each, a “**Warrant**”). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.39 per Common Share for a term of two years.

2.3 State the name of any joint actors.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

As at January 31, 2022, Crescat exercised control over 6,178,065 Common Shares, representing approximately 9.10% of the outstanding Common Shares, and 4,458,334 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 10,636,399 Common Shares representing approximately 14.70% of the issued Common Shares on a partially diluted basis as at January 31, 2022.

As at January 31, 2022, Crescat and the Joint Actors collectively exercised ownership and control over a total of 6,706,732 Common Shares (representing approximately 9.88% of the outstanding Common Shares) and 4,875,001 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 11,581,733 Common Shares representing approximately 15.92% of the outstanding Common Shares on a partially diluted basis as at January 31, 2022.
