On March 15, 2021, St-Georges Eco-Mining Corp., a shareholder of the Corporation, converted 1,386,016 Shares (the “Shares Received”) from warrants held (the “Conversion”).

The Share Received represent approximately 4.19% of the issued and outstanding shares of the Corporation on non-diluted basis. Prior to the date of the Conversion, St-Georges held 8,750,175 Shares of the Issuer and convertible securities entitles her to acquire 1,386,024 Shares (the “Convertible Securities”).
