The Corporation settled a debt together with an addition loan for the total amount of \$1,086,099.98 inclusive of accrued and unpaid interests (the “Debt Settlement”) with St-Georges Eco-Mining Corp. (“St-Georges”), a shareholder of the Corporation, effective May 17, 2023 by issuances of: i. 1,386,328 Shares of the Corporation (the “Debt Shares”), ii. 6,500,000 Share purchase warrants exercisable for a period of 3 years with an exercise price equal to \$0.15 per Share (the “Warrants”), and iii. a new unsecured non-convertible debenture in the principal amount of \$947,467.22 maturing on April 30, 2027 bearing interest at 18% payable quarterly in Shares at a price equal to the greater of: i. the 10 days VWAP of the Shares on CSE at the end of each quarter, and ii. \$0.10 per Share (the “New Debenture”).

The Debt Shares represent approximately 3.28% of the issued and outstanding Shares of the Corporation on non-diluted basis. Prior to the date of the Debt Settlement, St-Georges held 10,136,191 Shares of the Corporation.

Immediately after giving effect to the Debt Settlement, St-Georges owns or controls, directly or indirectly, 11,522,519 Shares, and Warrants and New Debenture entitling St-Georges to acquire a maximum number of 13,321,764 additional Shares, representing approximately 26.99% of the outstanding Shares of the Corporation and 44.35% of the outstanding Shares on a partially diluted basis, assuming the exercise of all of the Warrants and the payment of the Debenture's interest at the minimum conversion price of \$0.10 per Share on the Debenture's principal amount until maturity..
