On April 1st, 2021, Mr Turpin, President, CEO and shareholder of the Corporation, through Ranch Turpin Inc., received 4,720,000 Shares for consideration of acquisition of all of the issued and outstanding shares in the share capital of 3932095 Canada Inc. and Source Sainte-Cécile Inc. by the Corporation (the “Acquisition”). Concurrent with the Acquisition, Mr. Turpin assigned and disposed 2,000,000 Shares received from Acquisition which resulted a reception of 2,720,000 Share in total (the “Shares Received”).

The Share Received represent approximately 2.93% of the issued and outstanding shares of the Corporation on non-diluted basis. Prior to the date of the Acquisition, Mr. Turpin held 17,305,555 Shares of the Issuer and convertible securities entitles him to acquire 3,649,066 Shares (the “Convertible Securities”).

assuming exercises of the Convertible Securities.
