As a result of net purchases of common shares of the Issuer (“**Common Shares**”) acquired by Crescat in January 2023, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 17.50%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 2,167,712 Common Shares in Crescat’s holdings representing an increase of approximately 2.47% on a non-diluted basis and, assuming that all of the common share purchase warrants of the Issuer (“Warrants”) held by Crescat are exercised, an increase of approximately 2.30% on a partially diluted basis.

As at January 31, 2023, Crescat exercised control over 10,204,220 Common Shares, representing approximately 11.63% of the outstanding Common Shares, and 6,581,250 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 16,785,470 Common Shares representing approximately 17.79% of the issued Common Shares on a partially diluted basis as at January 31, 2023.

As at January 31, 2023, Crescat and the Joint Actors collectively exercised ownership and control over a total of 10,224,220 Common Shares (representing approximately 11.65% of the outstanding Common Shares) and 6,581,250 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 16,805,470 Common Shares representing approximately 17.82% of the

outstanding Common Shares on a partially diluted basis as at January 31, 2023.
