MADISON METALS INC. COMPLETES SHARE CONSOLIDATION

Common Shares held by shareholders through brokerage accounts will be consolidated with no further action required by the shareholder, and Common Shares held in certificated form directly by shareholders will have replacement a DRS receipt sent by mail or email as applicable to each registered shareholder's address on file with the Transfer Agent.
