On August 20, 2021 the Acquiror acquired 15,000 Common Shares of the Issuer through the facilities of the CSE at a price of \$0.29 per Common Share. This acquisition, when combined with acquisitions of Common Shares of the Issuer by the Acquiror since July 7, 2021, being the date of the last early warning report filed by the Acquiror with respect to the Issuer, exceeded 2% of the issued and outstanding Common Shares of the Issuer and triggered the requirement to file this report.

The requirement to file this report was triggered by the Acquiror acquiring 15,000 Common Shares of the Issuer through the facilities of the CSE on August 20, 2021. This resulted in a change in the Acquiror's holdings in the Common Shares of the Issuer from 12.19% to 12.24%.

The Acquiror acquired the Common shares of the Issuer that triggered the requirement of file this report.

Subsequent to the Transaction, the Acquiror owned and controlled 3,981,500 Common Shares and 416,667 warrants representing 12.24% of the issued and outstanding Common Shares of the Issuer based on a total of 32,525,906 Common Shares outstanding as of August 25, 2021 (or 13.35% assuming exercise of the warrants).
