On September 16, 2021 the Acquiror acquired 233,000 Common Shares of the Issuer through the facilities of the CSE at a price of \$0.343 per Common Share (the "Transaction").

The requirement to file this report was triggered by the Acquiror acquiring 233,000 Common Shares of the Issuer through the facilities of the CSE on September 16, 2021. This resulted in a change in the Acquiror's holdings in the Common Shares of the Issuer from 14.26% to 16.64%.

The Acquiror acquired the Common shares of the Issuer that triggered the requirement of file this report.

Subsequent to the Transaction, the Acquiror owned and controlled 5,411,500 Common Shares and 416,667 warrants representing 16.64% of the issued and outstanding Common Shares of the Issuer based on a total of 32,525,906 Common Shares outstanding as of September 16, 2021 (or 17.70% assuming exercise of the warrants).
