On December 30, 2022 Crest acquired 66,000 Common Shares of the Issuer through the facilities of the CSE at a price of \$0.179 per common share (the “**Transaction**”). This acquisition when combined with acquisitions of Common Shares of the Issuer acquired since November 14, 2022, being the date of the last early warning report filed by Crest with respect to the Issuer, exceeded 2% of the issued and outstanding Common Shares of the Issuer and triggered the requirement to file this report.

The requirement to file this report was triggered by Crest acquiring 66,000 Common Shares of the Issuer through the facilities of the CSE on December 30, 2022. This resulted in a change in Crest’s holdings in the Common Shares of the Issuer from 18.89% to 19.40%.

Crest acquired the Common shares of the Issuer that triggered the requirement of file this report.

Subsequent to the Transaction, Crest owns and controls 7,323,501 Common Shares representing 19.40% of the issued and outstanding Common Shares of the Issuer based on a total of 37,763,654 Common Shares outstanding as of January 11, 2023.
