

**NOTICE OF CHANGE IN FINANCIAL YEAR-END

1. Change of financial year-end

Boba Mint Holdings Ltd. (the "**Issuer**") changed its financial year-end from May 31 to June 30. The next financial year-end will occur on June 30, 2024.

2. Reason for the change

The Issuer (formerly known as Snowy Owl Gold Corp.) completed a transaction with Bluecorp Capital Corp., pursuant to which the Issuer acquired all the issued and outstanding securities of Bluecorp Capital Corp. The financial year-end of Bluecorp Capital Corp. is June 30 and so the Issuer decided to change its financial year-end to align with the financial year-end of the resulting operating business.
