3. News Release

A news release was disseminated on June 19, 2023 and subsequently filed under the Company’s profile on SEDAR.

4. Summary of Material Change

On May 25, 2023, the Company borrowed USD\$50,000 (the “**Loan**”) from Dr. Gary Benninger and issued a promissory note to Dr. Benninger. The Loan bears interest at an annual rate 8%, accruing daily and compounded monthly, is repayable on July 19, 2023, but can be extended 90 days to October 17, 2023 (the “**Maturity Date**”) and is convertible into common shares of the Company, at the election of Mr. Bharti, on or prior to the Maturity Date.

5. Full Description of Material Change

5.1 Full Description of Material Change

On March 22, 2023, the Company borrowed USD\$50,000 (the “**Loan**”) from Dr. Gary Benninger and issued a promissory note to Dr. Gary Benninger. The Loan bears interest at an annual rate 8%, accruing daily and compounded monthly, is repayable on the Maturity Date and is convertible into common shares of the Company, at the election of Mr. Bharti, on or prior to the Maturity Date

The Loan is a related party transaction pursuant to Multilateral Instrument 61-101 - *Protection of Minority Security Holders in Special Transactions* (“**MI 61-101**”). Dr. Benninger is CEO, a director and a control person of the Company, and, as such, Dr. Benninger has abstained from voting with respect to the Loan.

With respect to the Loan, the Company has relied on the exemption from the valuation requirement pursuant to section 5.5(b) (Issuer Not Listed on Specified Markets) of MI 61-101 and from the minority shareholder approval requirement prescribed by section 5.7(1)(a) (Fair Market Value Not More Than 25 Per Cent of Market Capitalization) of MI 61-101.

There is no undisclosed material information by the Company. The Company has at least one independent director, and all independent directors have approved the Loan.

The Company borrowed USD\$50,000 from Dr. Benninger and issued a promissory note to Dr. Benninger. The Loan bears interest at an annual rate 8%, accruing daily and compounded monthly, is repayable on the Maturity Date and is convertible into common shares of the Company, at the election of Dr. Benninger, on or prior to the Maturity Date.

(b) the purpose and business reasons for the transaction

The Company intends to use the funds from the Loan for general working capital purposes.

(c) the anticipated effect of the transaction on the issuer's business and affairs

The Company does not anticipate any material effect on its business and affairs as a result of the Loan.

Dr. Benninger, a director and president of AmmPower.

The board of directors of the Company approved the Loan and promissory note on May 25, 2023, with Dr. Benninger abstaining on voting on matters pertaining to the Loan and promissory note.

Pursuant to section 5.7(1)(a) of MI 61-101, the Company is exempt from obtaining minority approval of the Company's shareholders in respect of the Loan because the fair market value of the Loan is not greater than 25% of the market capitalization of the Company.
