On November 3, 2023, Aberdeen sold 7,000 common shares of AmmPower in the open market.

On November 17, 2023, Aberdeen sold 79,000 common shares of AmmPower in the open market.

On December 18, 2023, Aberdeen sold 1,889,000 common shares of AmmPower in the open market.

On December 22, 2023, Aberdeen sold 26,000 common shares of AmmPower in the open market.

On December 28, 2023, Aberdeen sold 246,000 common shares of AmmPower in the open market.

On December 29, 2023, Aberdeen sold 27,000 common shares of AmmPower in the open market.

On January 2, 2024, Aberdeen sold 2,000 common shares of AmmPower in the open market.

On January 4, 2024, Aberdeen sold 22,000 common shares of AmmPower in the open market.

On January 5, 2024, Aberdeen sold 1,000,000 common shares of AmmPower in the open market.

After the sale, Aberdeen held 33,113,925 common shares of AmmPower, representing 21.0% of AmmPower's issued and outstanding common shares and 21.5% on a partially diluted basis.
