On July 28, 2021, the Acquiror acquired 6,300,000 units at a price of \$0.06 per unit for total investment of \$378,000 by way of a private placement. Each unit consists of one Common Share of the Issuer and one share purchase warrant, each warrant exercisable to purchase one Common Share of the Issuer at a price of \$0.075 for a period of 60 months expiring July 28, 2026.

On July 28 2021, the Acquiror acquired 6,300,000 Common Shares and 6,300,000 warrants of the Issuer.

This transaction represents 22.58% in the Acquiror's securityholding percentage in the issued and outstanding Common Shares of the Issuer and 36.84% of the deemed outstanding Common Shares of the Issuer including the 6,300,000 warrants held by the Acquiror on an exercised basis.
