On November 30, 2023 the Acquiror acquired 3,750,000 units at a price of \$0.04 per unit for total investment of \$150,000 by way of a private placement (the “**Transaction**”). Each unit consists of one Common Share and one share purchase warrant, each warrant entitling the Acquiror to purchase one Common Share at a price of \$0.05 per share for five years expiring November 30, 2028. This Transaction represents 16.81% of the issued and outstanding common shares of the Issuer or 28.78% assuming exercise of the warrants held by the Acquiror.
