Item 1. Names of the Parties to the Transaction

The following corporate entities were parties to the transaction:

- a) Level 14 Ventures Ltd., a company incorporated under the *Business Corporations Act* (British Columbia) (the "**Issuer**");
- b) Green Mountain Resources Ltd. ("GMR"), a company incorporated under the *Business Corporations Act* (British Columbia), and a former subsidiary of the Issuer; and
- c) Kobe Resources Ltd. ("**Kobe**"), a company incorporated under the *Business Corporations Act* (British Columbia), and a former subsidiary of the Issuer.

Item 2. Description of the Transaction

On July 5, 2023, the Issuer completed the spin-out of Kobe and GMR pursuant to a plan of arrangement (the "**Arrangement**") under the *Business Corporations Act* (British Columbia).

As a result of the Arrangement as at 12:01 a.m. on July 5, 2023, among other things, shareholders of the Issuer (the "**Shareholders**") were entitled to receive: (i) one new common share of the Issuer; (ii) one-tenth of one common share of GMR for each common share of the Issuer held by such Shareholder immediately before the completion of the Arrangement; and (iii) one-tenth of one common share of Kobe for each common share of the Issuer held by such Shareholder immediately before the completion of the Arrangement. The warrants and stock options held by the Shareholders will also be adjusted in connection the Arrangement.

The Arrangement was approved by the shareholders of the Issuer on June 22, 2023. Final approval for the Arrangement was obtained from the Supreme Court of British Columbia on June 27, 2023.
