On Sept 23rd 2022 the Acquiror acquired 7,078,000 common shares of the Issuer representing approximately 10.94% of the issued and outstanding common shares of the Issuer. On Dec 2nd 2022 the Acquiror sold 3,150,000 shares of the Issue representing 4.87% of the outstanding shares. The Acquiror now controls 5,269,000 shares representing 8.14% of the outstanding shares.
