On December 29, 2023, Athena acquired (the “Acquisition”) beneficial ownership, direction and control of 10,000,000 Shares of the Corporation pursuant to a share purchase agreement dated December 22, 2023, between 2176423 Ontario Ltd. (a corporation controlled by Eric Sprott) and Athena. As a result of the Acquisition, Athena became an insider of the Corporation, having beneficial ownership over approximately 15.79% of the Corporation’s Shares.
