Management's Discussion & Analysis

This Management's Discussion and Analysis ("MD&A") supplements, but does not form part of, the financial statements of Archer Exploration Corp. ("Archer" or the "Company") and the notes thereto for the three and nine months ended June 30, 2022 and 2021 (collectively referred to hereafter as the "interim financial statements").

The following MD&A of the financial condition and results of operations of the Company has been prepared by management and should be read in conjunction with the interim financial statements of the Company in addition to the audited annual financial statements and related notes for the years ended September 30, 2021 and 2020. Additional information relating to the Company is available on SEDAR at www.sedar.com.

The first, second, third, and fourth quarters of the Company's fiscal years are referred to as "Q1", "Q2", "Q3" and "Q4", respectively. All amounts are presented in Canadian dollars, the Company's presentation currency, unless otherwise stated.

The interim financial statements have been prepared by management in accordance with International Financial Reporting Standards ("IFRS"), as issued by the International Accounting Standards Board and interpretations of the International Financial Reporting Interpretations Committee, applicable to the preparation of interim financial statements including International Accounting Standard 34 *Interim Financial Reporting*. All amounts are expressed in Canadian dollars unless otherwise stated. Other information contained in this document has been prepared by management and is consistent with the information contained in the interim financial statements.

The Company's certifying officers are responsible for ensuring that the financial statements and MD&A do not contain any untrue statement of a material fact, or omit to state a material fact required to be stated, or that is necessary to make a statement not misleading in light of the circumstances under which it was made. The Company's certifying officers certify that the financial statements together with the other financial information included in the filings fairly present, in all material respects, the financial condition, financial performance and cash flows of the Company as of the date of, and for the periods presented in the filings.

The Company's Audit Committee and the Board of Directors provide an oversight role with respect to all public financial disclosures by the Company. The Board of Directors approves the financial statements and MD&A after the completion of its review and recommendation for approval by the Audit Committee, which meets periodically to review all financial reports, prior to filing.

Description of the business

The Company was incorporated on October 26, 2018, and focuses on the exploration of mineral claims located in Quebec, Canada. The Company is focusing on the exploration of mineral claims located in Quebec, Canada. The Company's registered and records office is located at 400 Burrard Street - Suite 1050, Vancouver BC, V6C 3A6, Canada. On February 11, 2021, the shares of the Company began trading on the Canadian Stock Exchange under the symbol "RCHR".

The Company expenses all exploration, evaluation and development expenditures until management concludes that a future economic benefit is more likely than not to be realized.

Costs relating to the acquisition and claim maintenance of exploration and evaluation assets (including option payments and annual fees to maintain the property in good standing) are capitalized and deferred by property until the project to which they relate is sold, abandoned, impaired, or placed into production.

The Company has no operating cash flow, and its level of expenditures is dependent on debt and equity to finance its exploration operations. Therefore, it is difficult to identify any meaningful trends or develop an analysis from its cash flows.

Financial performance

As at June 30, 2022, current assets were \$1,019,551 (September 30, 2021 - \$1,498,277) and current liabilities were \$115,125 (September 30, 2021 - \$224,611), resulting in working capital of \$904,426 (September 30, 2021 - \$1,273,666). The decrease in working capital during the nine months ended June 30, 2022 is mainly due to decrease in prepaid expenses, increase in GST/HST receivable, and a decrease in trade and other payables.

As at June 30, 2022, the Company had total assets of \$1,019,551 (September 30, 2021 - \$1,535,777) which is comprised of \$628,286 of cash (September 30, 2021 - \$731,346), GST/HST receivable of \$73,559 (September 30, 2021 - \$5,597), \$317,706 of prepaid expenses (September 30, 2021 - \$761,334), and exploration and evaluation assets of \$nil (September 30, 2021 - \$37,500).

As at June 30, 2022, the Company had total liabilities of \$115,125 (September 30, 2021 - \$224,611), which comprises trade and other payables.

As at June 30, 2022, shareholders' equity was comprised of share capital of \$3,186,142 (September 30, 2021 - \$1,174,961), warrants reserve of \$699,457 (September 30, 2021 - \$429,952), share-based payments reserve of \$347,129 (September 30, 2021 - \$21,956), shares to be issued of \$nil (September 30, 2021 - \$427,500), and a deficit of \$3,328,302 (September 30, 2021 - \$743,203) for a total shareholders' equity of \$904,426 (September 30, 2021 - \$1,311,166).

The weighted average number of common shares outstanding for the three and nine months ended June 30, 2022 was 32,969,292 and 28,447,607, respectively (2021 - 13,788,250 and 13,094,261).

Liquidity and capital resources

The Company is in the exploration stage and therefore has no cash flow from operations. Its only source of funds since incorporation has been from the issuance of common shares, special warrants, and units.

On October 1, 2021, the Company closed a non-brokered private placement for gross proceeds of \$1,499,999 from the issuance of 5,999,998 units (the "Units") at a price of \$0.25 per Unit (the "Private Placement"). Each Unit consists of one common share and one-half warrant. A whole warrant may be exercised for one common share at price of \$0.50 for a period of twenty-four months from the closing date of the Private Placement. Gross proceeds were allocated between share capital and warrants reserve using the relative fair value method. As a result, \$1,230,494 was allocated to share capital and \$269,505 was allocated to warrants reserve.

During the nine months ended June 30, 2022, the Company used cash of \$1,846,069 in operating activities (2021 - \$96,524) primarily related to exploration activities, filing and legal fees as well as professional fees, and changes in non-cash working capital.

During the nine months ended June 30, 2022, the Company used cash of \$109,990 in investing activities (2021 - \$66,832) for expenditures on exploration and evaluation assets.

During the nine months ended June 30, 2022, the Company received cash of \$1,852,999 from financing activities (2021 - \$120,000) related to proceeds from issuance of units, proceeds from options exercise and warrants exercise.

The Company is in the process of exploring mineral claims. The Company has not yet determined whether or when the claims could be economically viable.

While the information in the financial statements has been prepared in accordance with IFRS on a going concern basis, which presumes the realization of assets and discharge of liabilities in the normal course of business for the foreseeable future, there are conditions and events that cast significant doubt on the validity of this presumption. The Company's ability to continue as a going concern is dependent upon achieving profitable operations and upon obtaining additional financing. While the Company is making its best efforts in this regard, the outcome of these matters cannot be predicted at this time.

As of the date of the interim financial statements, COVID-19 has had no impact on the Company's ability to access and explore its current properties, but may impact the Company's ability to raise funding or explore its properties should travel restrictions related to COVID-19 be extended or expanded in scope.

Results of operations

The net loss and comprehensive loss for nine months ended June 30, 2022 was \$2,585,099 (2021 - \$326,339), comprise of exploration and evaluation costs of \$168,494 (2021 - \$40,701), filing and legal fees of \$442,362 (2021 - \$nil), general and administrative costs of \$117,687 (2021 - \$1,097), management fees of \$144,672 (2021 - \$46,113), marketing costs of \$23,517 (2021 - \$nil), professional fees of \$410,806 (2021 - \$58,980), rent of \$36,000 (2021 - \$nil), share-based payments of \$325,360 (2021 - \$15,050), foreign exchange loss of \$7,377 (2021 - \$nil), impairment of option agreement rights of \$147,490 (2021 - \$164,413), write-off of deposit of \$761,334 (2021 - \$nil) and interest income of \$nil (2021 - \$15) all of which, except for the foreign exchange loss and impairment of option agreement, have increased over the prior year comparable period due to the Company having increased activity. Professional fees consists of audit, accounting, and consulting fees to operate the business within compliance requirements.

The net loss and comprehensive loss for three months ended June 30, 2022 was \$1,271,055 (2021 - \$109,622), comprising of exploration and evaluation costs of \$14,750 (2021 - \$40,701), filing and legal fees of \$43,426 (2021 - \$nil), general and administrative costs of \$38,050 (2021 - \$959), management fees of \$19,875 (2021 - \$32,600), marketing costs of \$12,543 (2021 - \$nil), professional fees of \$155,958 (2021 - \$22,613), rent of \$12,000 (2021 - \$nil), share-based payments of \$69,045 (2021 - \$12,749), foreign exchange gain of \$3,416 (2021 - \$nil) impairment of option agreement rights of \$147,490 (2021 - \$nil), and write-off of deposit of \$761,334 (2021 - \$nil). Except for exploration and evaluation expenses as well as management fees, expenses have increased over the prior year comparable period due to the Company having increased activity.

Proposed transactions

Montclair Mining Ltd. And Nicellco Metals Limited

On October 15, 2021, the Company signed a non-binding letter of intent with Montclair Mining Ltd. ("MML") and Nicellco Metals Limited ("NML"), pursuant to which the Company will acquire all of the issued and outstanding common shares of MML and NML. Pursuant to the letter of intent, the Company advanced \$291,587 (USD \$235,000) to NML which is included in prepaid expenses at June 30, 2022.

Echelon Minerals Ltd.

On September 7, 2021, the Company signed a letter of intent with Echelon Minerals Ltd. ("Echelon"), pursuant to which the Company would have acquired all of the issued and outstanding common shares of Echelon, which owns the rights to the Zanzui Prospecting Licence. Pursuant to the letter of intent, the Company paid Echelon a refundable deposit of \$761,334 (USD \$600,000).

During the nine months ended June 30, 2022, the Company terminated the letter of intent with Echelon. In connection with the termination of the letter of intent, the Company wrote off the deposit of \$761,334.

Use of estimates and significant accounting policies

Preparing financial statements requires management to make estimates and assumptions that affect the reported results. The estimates are based on historical experience and other assumptions believed to be reasonable under the circumstances. Critical accounting policies are disclosed in the annual financial statements for the years ended September 30, 2021 and 2020.

Transactions between related parties

Key management personnel include those persons having authority and responsibility for planning, directing and controlling the activities of the Company as a whole. The Company has determined that key management personnel consist of executive and non-executive members of the Company's Board of Directors and Corporate Officers.

Subsequent event

On July 12, 2022, the Company entered into an asset purchase agreement with Wallbridge Mining Company Limited ("Wallbridge") whereby the Company will acquire from Wallbridge a 100% interest in certain mineral properties located in Quebec and Ontario in exchange for 198,635,786 common shares of the Company. The Company will also grant to Wallbridge a net smelter return royalty on production from certain of the acquired assets.
