MANAGEMENT'S DISCUSSION AND ANALYSIS

FOR THE THREE MONTHS ENDED NOVEMBER 30, 2022

Introduction

This Management's Discussion and Analysis ("MD&A") of Prospect Ridge Resources Corp is the responsibility of management and covers the period ended November 30, 2022. The MD&A takes into account information available up to and including January 20, 2023 and should be read together with the unaudited condensed interim financial statements for the period ended November 30, 2022, and the audited financial statements for the year ended August 31, 2022. The Company prepares its financial statements in accordance with International Financial Reporting Standards ("IFRS").

Throughout this document the terms we, us, our, and the Company refer to Prospect Ridge Resources Corp. All financial information in this document is derived from the financial statements of the Company, which have been prepared in accordance with IFRS, except share and per share amounts, or unless otherwise indicated.

Description of Business

Prospect Ridge Resources Corp. was incorporated under the laws of the Province of British Columbia. The Company is principally engaged in the acquisition and exploration of resource properties in Canada. The head office, records office, and principal address of the Company is 10th Floor-595 Howe Street, Vancouver, British Columbia, V6C 2T5.

The Company is in the process of investing in potential new acquisitions and exploring and evaluating its resource properties and has not yet determined whether the properties contain ore reserves that are economically recoverable. The Company's primary focus is the Holy Grail property in Terrace, BC.

Performance Summary and Subsequent Events

During and subsequent to the period ended November 30, 2022, the Company:

- (a) Issued 700,000 common shares valued at \$133,000 and issued 50,000 Finder's shares valued at \$6,750 per Knauss Creek Property option agreement.
- (b) Issued 1,000,000 common shares valued at \$250,000 and issued 142,857 Finder's shares valued at \$65,714 per Holy Grail Property option agreement.
- (c) Entered into agreements to issue an aggregate of 124,419 common shares at \$0.20 per share to settle \$24,884 in accounts payable; the agreements remain subject to regulatory approval.

COVID-19 Update

In March 2020, the World Health Organization declared coronavirus COVID-19 a global pandemic. This contagious disease outbreak, and any related adverse public health developments, has adversely affected workforces, economies, and financial markets globally. The Company continues to work to adapt to changing circumstances, travel restrictions and impacts on movement of goods and services. These conditions may impact the Company's ability to execute on its business plans.

Exploration Results

2022 Highlights

The Company has completed seven drill holes on the Knauss Creek property. The two first holes were drilled on the Jay Veins, which were followed by four holes in the historic Dorreen area and a last one again on the Jay Veins area.

The prospection ended mid-October and all the equipment was packed and stored until the next field season.

2021 Highlights

2021 field crews have collected over 500 rock samples, over 850 soils and cut over 40 meters of channel samples through a systematic property-wide exploration program efficiently rank and generate drilling vectors.

Key results from rock sampling available in Table 1, with highlights including:

- Sample #A0600805 from the Shock & Awe target containing 50.00 g/t gold, 311.0 g/t silver, 0.09% copper, 2.32% lead, and 1.92% zinc
- Sample #A0600810 from the Shock & Awe target containing 23.40 g/t gold, 17.8 g/t silver, 0.04% copper, 0.85% lead, and 0.23% zinc
- Sample #A0600829 from the 4shore target containing 21.30 g/t gold, 38.3 g/t silver, and 1.62% copper
- All assay results were received and are being compiled.

The 2021 program has identified multiple new targets and mapped 7 extensive mineralized zones that cross the Property including samples with visible gold (VG) at four sites.

Exploration Projects

Holy Grail Property

Property Description and Ownership

The Holy Grail Property is located 10 kilometers north of Terrace. The Property is easy-accessible, bounded by two highways with CN rail, high tension power crossing the Property and a network of logging roads over approximately 80% of the Property which will make for a very cost-effective exploration and strong feasibility. Some of the key areas are located below the tree line and can be worked nearly year-round. The Optionor is the registered owner (100%) of all the claims of the Property.




Figure 1: Holy Grail property

Geology and Mineralization Styles

During the due diligence process the Prospect Ridge team ground truthed multiple targets that were generated from the data collected in 2020. The program identified 3 main styles of mineralization on the Property: 1) Structurally controlled and intrusion related veins, stockwork and breccias with gold and silver mineralization; 2) porphyry intrusives with copper, gold, and molybdenum mineralization; and 3) Eskay Creek or Kuroko volcanogenic style massive sulphides (VMS).

The 2021 and 2022 exploration focus was primarily on the significant gold and polymetallic mineralization that occurs in proximity to regional faults in associated structures. Mineralization is structurally controlled, and intrusion related with mineralization persisting through all intersected lithologies. To date, mineralization has been observed within sedimentary, volcanic, intrusive, and metamorphic lithologies on the Property.

Quality Assurance and Control

Sample analysis and assaying have been conducted by ALS Global Laboratories (Geochemistry Division) in Vancouver, Canada (an ISO/IEC 17025:2017 accredited facility). A secure chain of custody is maintained in transporting and storing of all samples. Certified assay standards, duplicate samples and blanks are routinely inserted into the sample stream to ensure integrity of the assay process. Rock samples are crushed to 70% less than 2 millimeters, and a 250-gram sample is split with a riffle splitter. The split is pulverized to 85 per cent less than 75 microns and 50-gram charges prepared. Gold was assayed using a fire assay with atomic emission spectrometry and gravimetric finish when required (+10 g/t Au). Analysis by four acid digestions with 48 element ICP-MS analysis was conducted on all samples with silver and base metal overlimits being re-analyzed by atomic absorption or emission spectrometry. The Company cautions that rock chip samples from outcrop/bedrock are selective by nature and may not be representative of the mineralization hosted on the Property.

All scientific or technical information included in this MD&A has been reviewed, verified and approved by Yan Ducharme, P.Geol., President of the Company and a qualified person as defined by National Instrument 43-101.

Knauss Creek Property Overview

Property Description and Ownership




Figure 2: Knauss Creek property

The Property mineral claims are located in the Ominica Mining Division in British Columbia. The southern portion of the Property is approximately 35 km northeast of the Town of Terrace (see Figure 2). The Property covers 3,152 hectares in mineral claims. The Property is fully owned by the Company.

Geology and Mineralization

The Property is underlain by a sequence of stratified argillites, sandstones, and conglomerates of the Jurassic to Cretaceous age Bowser Lake Group sedimentary rocks and Upper Triassic to Middle Jurassic Hazelton Group volcano-sedimentary rocks. These are intruded by granodioritic units ranging from Cretaceous to Tertiary in age. Hornfels alteration halos occur around the intruding granodioritic bodies. Bowser Lake and Hazelton group rocks have been intruded by the Eocene aged Carpenter Creek Pluton in the southwestern part of the property and by Eocene rhyolite dykes in the central part of the property.

The Property lies south of the "Golden Triangle" area of northwestern British Columbia where extensively occurring precious and base-metal mineralization have historically been discovered.

The Knauss Creek Property is being explored for polymetallic veins and potential associated skarn and porphyry mineralization within an orogenic geological environment. Placer deposits were mined in creeks adjacent, west and east, to the Property during the early part of the 20th century.

Resource Property Interests - Exploration and evaluation expenditures

Activities of the Company for the period ended November 30, 2022 focused on the continuing exploration work on its properties as indicated in the Exploration Program and Results described above.

Results of Operations for the three months ended November 30, 2022

During the three-month period ended November 30, 2022, the Company incurred a net loss of \$775,622 as compared to \$1,206,866 for the period ended November 30, 2021. Significant items making up the loss include:

- Investor relation expense of \$112,305 (2021 \$234,168) as the Company decreased its investor relations expense for the period.
- Consulting and Management fees of \$89,500 (2021 \$93,500) related to the payment to the management teams and directors of the Company.
- Professional fees of \$24,973 (2021 \$31,263) related to audit, accounting fees and legal fees.
- Exploration and evaluation expenditures of \$686,923 (2021 \$301,030) as the Company continues to ramp-up exploration work following initial success on its projects. Please refer to the exploration and evaluation expenditures table above for a detailed breakdown.
- Depreciation expense of \$38,564 (2021 \$11,493) as the Company recorded office lease right-ofuse assets and purchased additional equipment during the period.

Liquidity

The Company's historical capital needs have been met by issuance of shares. As at November 30, 2022, the Company had a working capital of \$2,886,733 (August 31, 2022 - \$3,609,153). The Company proposes to meet any additional financing requirements through equity financing. The Company's cash position as at November 30, 2022 was \$2,176,374 (August 31, 2022 - \$3,168,488).

Operating activities: The Company does not generate cash from operating activities. Net cash used in the Company for operating activities, which includes exploration activities, for the period ended November 30, 2022 was \$918,399 (2021 - \$2,043,851), including net changes in non-cash working capital of \$174,696 (2021 - \$1,367,986 cash used).

Investing activities: Net cash used by the Company for investing activities for the period ended November 30, 2022, was \$49,509 (2021 - \$278,463), reflecting the Company's acquisitions of mineral property and equipment, offset by proceeds on sale of equipment of \$59,000 (2021 - \$nil).

Financing activities: Net cash used in financing activities for the period ended November 30, 2022 was \$24,206 (2021 - \$5,939,505 cash generated), comprised entirely of lease payments completed in the period (2021 - \$1,561 lease payments completed). During the period ended November 30, 2021, the Company also received proceeds from share issuances of \$6,085,000, from the exercise of warrants of \$11,320, offset by \$155,254 in share issuance costs.

The Company does not have operations that generate positive cash flows and it is unlikely that it will generate cash flows from operations in the foreseeable future. Cash requirements will depend primarily on the extent of future exploration programs. Subsequent phases will depend, both on cost and duration, and on results from previous phases, and it is therefore extremely difficult to predict future cash requirements.

Off-Balance Sheet Arrangements

As at November 30, 2022, the Company had no material off-balance sheet arrangements such as guarantee contracts, contingent interest in assets transferred to an entity, derivative instruments obligations or any obligations that trigger financing, liquidity, market or credit risk to the Company.

Proposed Transactions

Except as elsewhere disclosed in this document, there are no other proposed transactions under consideration.

Capital Risk Management

The Company's objective when managing capital is to maintain its ability to continue as a going concern in order to provide returns and/or benefits for shareholders.

The Company manages its capital structure and makes adjustments to it, based on the funds available to the Company, in order to support the administration of its corporate affairs and to provide funds for the development of its business. The Board of Directors does not establish quantitative return on capital criteria

for management but rather relies on the expertise of the Company's management and consultants to sustain future development of the business.

The Company has no revenue-generating operations and as such is dependent upon external financings to fund activities. In order to develop its business and pay for administrative costs, the Company will spend its existing working capital and raise additional funds as required.

Management reviews its capital management approach on an ongoing basis and believes that this approach is reasonable given the size of the Company.

There were no changes in the Company's approach to capital management during the period ended November 30, 2022. The Company is not subject to externally imposed capital requirements.

Financial Instruments

Financial assets and liabilities are classified in the fair value hierarchy according to the lowest level of input that is significant to the fair value measurement. Assessment of the significance of a particular input to the fair value measurement requires judgment and may affect placement within the fair value hierarchy levels.

Fair value estimates of financial instruments are made at a specific point in time, based on relevant information about financial markets and specific financial instruments. As these estimates are subjective in nature, involving uncertainties and matters of significant judgment, they cannot be determined with precision. Changes in assumptions can significantly affect estimated fair values.

The Company's risk exposures and the impact on the Company's financial instruments are summarized below:

Credit risk

Credit risk is the risk of loss associated with counterparty's inability to fulfill its payment obligations. The Company's receivables consist mainly of goods and services tax receivables due from the Government of Canada. As at November 30, 2022, the Company's exposure to credit risk is minimal.

Liquidity risk

The Company's approach to managing liquidity risk is to ensure that it will have sufficient liquidity to meet liabilities when due. As at November 30, 2022, the Company had a cash balance of \$2,176,374 to settle current liabilities of \$112,570. All of the Company's accounts payable and accrued liabilities have contractual maturities of 30 days or are due on demand and are subject to normal trade terms. Management intends to meet its liabilities by actively pursuing investors.

Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices.

a) Interest rate risk

As at November 30, 2022, the Company was not subject to or exposed to any interest rate risk as it had no variable interest debt or investments.

b) Foreign currency risk

As at November 30, 2022, the Company is not exposed to foreign currency risk.

c) Price risk

The Company is exposed to price risk with respect to commodity and equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market. Commodity price risk is defined as the potential adverse impact on earnings and economic value due to commodity price movements and volatilities. As at November 30, 2022, the Company was not exposed to any equity or commodity price risks.

Significant Accounting Judgements, Estimates and Assumptions

The preparation of financial statements requires management to make estimates about, and apply assumptions or judgment to, future events and other matters that affect the reported amounts of the Company's assets, liabilities, revenues, expenses and related disclosures. Assumptions, estimates and judgments are based on historical experience, expectations, current trends and other factors that management believes to be relevant at the time at which the Company's financial statements are prepared.

The Company's significant accounting judgements, estimates and assumptions are disclosed in Note 3 of the audited financial statements for the year ended August 31, 2022.

Risks and Uncertainties

In conducting its business, the Company, like all exploration-stage mineral exploration companies, faces a variety of risks uncertainties. While unable to eliminate all of them, the Company aims at managing and reducing such risks as much as possible.

Exploration and Development - Resource exploration and development is a highly speculative business, characterized by a number of significant risks including, but not limited to, unprofitable efforts resulting not only from the failure to discover mineral deposits but also from finding mineral deposits that, though present, are insufficient in quantity and quality to return a profit from production. Few exploration projects successfully achieve development due to factors that cannot be predicted or anticipated, and even one such factor may result in the economic viability of a project being detrimentally impacted such that it is neither feasible nor practical to proceed. The Company closely monitors its activities and those factors that could impact them and employs experienced consulting to assist in its risk management and to make timely adequate decisions.

Title Risks - Title to mineral properties involves certain inherent risks due to the difficulties of determining the validity of certain claims, as well as the potential for problems arising from the frequently ambiguous conveyance history characteristic of many mineral properties.

Permitting Risks - The development of mineral resources in British Columbia is subject to a comprehensive review, approval and permitting process involving various provincial and regional agencies, in addition to the various First Nations groups that have jurisdiction in the Company's area of claims. There can be no assurance given for the required approvals and permits for a mining project, even if technically and economically warranted, can be obtained in a timely or cost-effective manner.

Fluctuating Metal Prices - Factors beyond the control of the Company have a direct effect on global metal prices, which have fluctuated widely, particularly in recent years. Consequently, the economic viability of any of the Company's exploration projects and the Company's ability to finance the development of its projects cannot be accurately predicted and may be adversely affected by fluctuations in metal prices.

Environmental Regulations Permits and Licenses - Environmental laws and regulation could also impact the viability of a project. The Company has ensured that it has complied with these regulations, but there can be changes in legislation outside the Company's control that could also add a risk factor to a project.

Competition - The mineral exploration industry is intensely competitive in all its phases, and the Company competes with some companies that have greater financial and technical resources. Competition could adversely affect the Company's ability to acquire suitable properties or prospects in the future.

Future Financings - The Company's continued operation will be dependent in part upon its ability procure additional financing. To date, the Company has done so through a combination of: (i) equity financing; and (ii) cash payments received as property option payments from third parties. The current state of global equity markets has had a direct effect on the ability of exploration companies, including the Company, to finance project acquisition and development through the equity markets. There can be no assurance that forms of financing can be obtained at a future date. Failure to obtain additional financing on a timely basis may cause the Company to postpone development plans, forfeit rights in some or all of the properties or joint ventures, or reduce or terminate some or all of the operations.

Price Volatility of Publicly Traded Securities - During recent months, global securities markets have experienced a high level of price and volume volatility, and the market prices of securities of many companies have experienced wide fluctuations in price that have not necessarily been related to the operating performance, underlying asset values or prospects of such companies. There can be no assurance that continual fluctuations in price will not occur.
