# GOAT INDUSTRIES ANNOUNCES DEBT SETTLEMENTS

Vancouver, British Columbia, Canada – April 9, 2024 – GOAT Industries Ltd. (the "Company" or "GOAT") (CSE: GOAT) (OTC: BGTTF) (FWB: 26B.F) announces that it intends to enter into debt settlement agreements with certain creditors of the Company to settle outstanding indebtedness in the aggregate amount of \$41,912.01 (the "Debt") in exchange for the issuance of 465,689 units (the "Units") at a price of \$0.09 per Unit. Each Unit will be comprised one common share in the capital of the Company (a "Common Share") and one common share purchase warrant (a "Warrant"), with each Warrant exercisable for a period of two (2) years at a price of C\$0.15 per Warrant.

The company is finalizing the debt settlement to enhance its financial standing by diminishing its current liabilities. All securities issued by the Company will be subject to a standard four-month hold period from the date of issue. The Company has received acceptance of the debt settlement from the Canadian Securities Exchange.
