On June 2, 2023, Northern Superior received the Consideration Shares in satisfaction of the scheduled share issuance required to be made by Rockland under the terms of the Option Agreement (the "**Share Issuance Payment**"). The Consideration Shares were issued at a deemed price of \$0.065 per share.

Immediately after the Share Issuance Payment, Northern Superior owns or has control or direction over, 10,800,000 common shares of Rockland, representing approximately 16.29% of the issued and outstanding common shares of Rockland on a non-diluted basis
