ZOGLO'S INCREDIBLE FOOD LATE TO FILE Q1-2022 RESULTS

Toronto, ON – May 30, 2022: [Zoglo's Incredible Food Corp.](#) (CSE: ZOG) (FSE: 7UT) (“Zoglo’s” or the “Company”), announces that its first quarter interim financial statements for the three months ended March 31, 2022, including the related management discussion and analysis, and CEO and CFO certifications (collectively, the "Interim Financial Filings") were not filed by the required filing deadline of May 30, 2022 (the "Filing Deadline").

The Interim Financial Filings were not filed on or before the Filing Deadline due to delays on filing the 2021 Annual Financial Filings, as previously announced on May 9, 2022, as a result of delays in audit completion. The Company continues to work on completing the Annual and Interim Financial Filings and expects to be able to file the Annual and Interim Financial Filings on or before June 30, 2022.

The Company will provide updates as further information relating to the Annual and Interim Financial Filings becomes available.

The Ontario Securities Commission issued a failure-to-file cease trade order (“CTO”) under *National Policy 11-207 - Failure-to-File Cease Trade Orders and Revocations in Multiple Jurisdictions* affecting all the Company's securities on May 6, 2022. The CTO will remain in effect until all Company filings have been brought up to date.

The Company confirms as of the date of this news release that there is no insolvency proceeding against it and there is no other material information concerning the affairs of the Company that has not been generally disclosed.
