NSJ GOLD CORP. MANAGEMENT DISCUSSION AND ANALYSIS

For the nine months ended August 31, 2022 (Expressed in Canadian Dollars, except where noted)

1. EFFECTIVE DATE AND FORWARD-LOOKING STATEMENTS

a) Reporting Period and Effective Date

This management discussion and analysis of financial position and results of operations ("MD&A"), prepared as of October 24, 2022 provides an analysis of the operations and financial results of NSJ Gold Corp. ("the Company") for the nine months ended August 31, 2022. This MD&A should be read in conjunction with the condensed interim financial statements of the Company and related notes thereto as at and for the nine months ended August 31, 2022 which have been prepared in accordance with International Financial Reporting Standards ("IFRS" or "GAAP") as issued by the International Accounting Standards Board ("IASB"). All dollar amounts presented in this MD&A are Canadian dollars unless otherwise stated.

b) Forward-looking Statements

This MD&A contains forward-looking statements and forward-looking information (collectively, "forward-looking statements") within the meaning of applicable Canadian and US securities legislation. These statements relate to future events or the future activities or performance of the Company. All statements, other than statements of historical fact are forward-looking statements. Forward-looking statements are typically identified by words such as: believe, expect, anticipate, intend, estimate, postulate, and similar expressions, or which by their nature refer to future events. Historical results of operations and trends that may be inferred from the following discussion and analysis may not necessarily indicate future results from operations. In particular, the Company has moved from a private corporation operating with very limited capital and therefore with very restricted operations, to a publicly traded venture issuer. Accordingly, drawing trends from the Company's limited operating history is difficult.

2. DESCRIPTION OF THE BUSINESS

NSJ Gold Corp. (the "Company") is in the business of the exploration and evaluation of mineral properties. The Company was incorporated under the Business Corporations Act of British Columbia on May 22, 2020. On March 8, 2021, the Company listed its shares on the Canadian Securities Exchange ("CSE") and trades under the symbol NSJ. The address of the Company's registered and records office is Suite 101, 17565 58 Avenue, Surrey, British Columbia, V3S 4E3 Canada.

The Company entered into an option agreement dated August 14, 2020, as amended on November 25, 2020 (the "Option Agreement") to acquire a 100% interest in certain claims comprising the Golden Hills Project (the "Golden Hills Property") located in Arizona, USA. The Golden Hills Property is subject to a 3% Net Smelter Return as payable to the Vendor.

3. OUTLOOK AND GOING CONCERN

a) Outlook

The Company's primary business is the acquisition and exploration of mineral properties. The Company's exploration and evaluation assets do not presently host any known mineral deposits nor, given the high degree of risk involved, can there be any assurance that its exploration activities will result in such deposits being located or, ultimately, a profitable mining operation in the future.

In 2020, there was a global outbreak of coronavirus that has resulted in changes in global supply and demand of certain mineral and energy products. These changes, including a potential economic downturn and any potential resulting direct and indirect negative impact to the Company cannot be determined, but they could have a prospective material impact to the Company's project exploration activities, cash flows and liquidity. Various restrictions on gatherings, work and access to remote communities near the Company's project may also impact the Company's ability to perform exploration activities at the project.

b) Going Concern

The Company incurred a loss of \$302,995 during the nine months ended August 31, 2022, and has an accumulated deficit as at August 31, 2022 of \$1,274,892. Further, the Company has no source of operating cash flows, and there is no assurance that sufficient funding (including adequate financing) will be available to conduct required exploration and development of its mineral property projects. These factors indicate that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern.

The application of the going concern concept is dependent upon the Company's ability to generate future profitable operations and receive continued financial support from its creditors and shareholders. These condensed financial statements do not give effect to any adjustments that might be required should the Company be unable to continue as a going concern.

Three months ended August 31, 2022

For the three months ended August 31, 2022, the Company had no revenue and a net loss of \$82,745 compared to a loss of \$411,224 for the three months ended August 31, 2021. Net loss primarily relates to management fees of \$60,000 (2021 - \$Nil), professional fees of \$6,000 (2021 - \$20,720), office and miscellaneous expenses of \$6,690 (2021 - \$9,399), marketing fees of \$Nil (2021 - \$68,495) transfer agent and filing fees of \$2,819 (2021 - \$Nil) and stock-based compensation of \$1,245 (2021 - \$249,799).

Nine months ended August 31, 2022

For the nine months ended August 31, 2022, the Company had no revenue and a net loss of \$302,995 compared to a loss of \$723,380 for the nine months ended August 31, 2021. Net loss primarily relates to management fees of \$175,000 (2021 - \$Nil), professional fees of \$6,000 (2021 - \$92,973), office and miscellaneous expenses of \$24,844 (2021 - \$46,606), marketing fees of \$37,947 (2021 - \$118,975) transfer agent and filing fees of \$6,970 (2021 - \$Nil) and stock-based compensation of \$35,942 (2021 - \$249,799).

Total liabilities at August 31, 2022, totaled \$34,657 (November 30, 2021 - \$47,548). This amount consists of accrued fees payable to related parties and other payables.

Shareholders' equity as at August 31, 2022 consists of share capital of \$2,059,500 (November 30, 2021 - \$2,059,500), reserves of \$378,400 (November 30, 2021 - \$342,458) and a deficit of \$1,274,892 (November 30, 2021 - \$971,897) for net equity of \$1,163,008 (November 30, 2021 - \$1,430,061).

Working capital (defined as current assets less current liabilities) was \$610,795 as at August 31, 2022 (November 30, 2021 - \$951,083).

The number of common shares outstanding at August 31, 2022 and November 30, 2021 was 23,309,000.

d) Summary of Mineral Property Interests

The Company entered into an option agreement dated August 14, 2020, as amended November 25, 2020 (the "Option Agreement") to acquire a 100% interest in certain claims comprising the Golden Hills Project (the "Golden Hills Property") located in Arizona, USA. Pursuant to the Option Agreement, to exercise the option the Company is required to pay a total of USD299,000 over a five year period with the first payment of USD24,000 due on or before March 28, 2021 (paid) and pay annual claim maintenance fees totaling USD15,510. The Company is also obligated to complete an exploration development program totaling USD4,635,000 per the following schedule:

- USD85,000 on or before the first anniversary date of the original agreement (completed)
- USD150,000 on or before the second anniversary date of the original agreement (completed)
- USD400,000 on or before the third anniversary date of the original agreement
- USD1,000,000 on or before the fourth anniversary date of the original agreement
- USD3,000,000 on or before the fifth anniversary date of the original agreement

The Golden Hills Property is subject to a 3% Net Smelter Return as payable to the Vendor.

5. LIQUIDITY AND CAPITAL RESOURCES

a) Liquidity

Since incorporation, the Company's capital resources have been limited. The Company has had to rely upon the sale of equity securities for the cash required for property acquisition payments, office and miscellaneous expenses and accounting, audit and legal fees, among other expenses.

During the nine months ended August 31, 2022 the Company had no share issuances.

During the year ended November 30, 2021 the Company completed two financing raising a total of \$1,229,000 (net of finder's fees totaling \$47,600). On January 18, 2021 the Company issued 1,937,000 special warrants and on January 20, 2021 the Company issued 4,446,000 special warrants (the "Special Warrants"). Each Special Warrant entitles the holder to acquire, without payment of any consideration in

addition to that paid for the Special Warrant, one previously unissued unit in the capital of the Company. Each Unit is comprised of one common share in the capital of the Company and one-half of one common share purchase warrant where each whole Warrant entitles the holder to purchase one additional common share at an exercise price of \$0.40 per share for a period of 18 months.

The Company expects that its cash position of \$570,094 as at the most recent month end being August 31, 2022, will be sufficient for the Company to become operational to begin meeting its objectives and milestones. Once the Company is operational, it will require additional working capital in order to increase its growth rate and may seek to raise additional funds via one or more private placements.

b) Capital Resources

As at August 31, 2022, the Company's share capital was 2,059,500 (November 30, 2021 - 2,059,500) representing 23,309,000 (November 30, 2021 – 23,309,000) issued and outstanding common shares without par value.

During the nine months ended August 31, 2022 the Company has not issued any additional shares.

During the year ended November 30, 2021, the Company issued the following:

- a) The Company received notice of receipt for its long form prospectus from the British Colombia Securities Commission. As such all outstanding Special Warrants were exercised and the Company issued 9,104,000 common shares to the special warrant holders for no additional consideration.
- b) On March 15, 2021 the Company issued 105,000 at a price of \$0.36 per share for services rendered by a director of the Company (Note 7).
- c) On May 26, 2021 the Company issued 100,000 shares to settle \$21,000 due to a director of the Company (Note 7). The fair value of the shares on the date of issuance was \$18,500 and the Company recorded a gain of \$2,500.

Under the escrow agreement dated January 27, 2021, 10% of the escrowed common shares were to be released from escrow on the date of listing on the CSE. Subsequent to listing (March 8, 2021), an additional 15% are to be released every six months over a thirty-six month period. As at August 31, 2022, a total of 8,400,000 shares and 3,000,000 warrants were held in escrow (November 30, 2021 – 10,500,000 shares and 3,750,000 warrants).

During the nine months ended August 31, 2022 the Company recognized \$35,942 (2021 - \$Nil) in stock-based compensation for the vesting of options.

During the year ended November 30, 2021, the Company granted 1,690,000 stock options exercisable at a price of \$0.20 with a 5-year life, 150,000 stock options exercisable at a price of \$0.30 with a 5-year life and 200,000 stock options exercisable at a price of \$0.25 with a 5-year life. The Company uses the Black-Scholes Option Pricing Model to calculate the fair value of the options granted. The Company utilized the following weighted average assumptions: volatility - 152%, average risk-free rate -0.77% and a five-year term. Accordingly, the estimate grant date fair value of the options was \$378,401. All options granted vest over a period of 1 year with 25% of the options vesting every 3 months. During the year ended November 30, 2021 the Company recorded \$342,458 in share-based compensation in relation to these grants.

6. TRANSACTIONS WITH RELATED PARTIES

During the nine months ended August 31, 2022 and 2021, the Company incurred the following transactions with key management personnel:

- \$110,000 (2021 \$90,000 recorded as consulting fees) in management fees to JNS Capital Corp., a company controlled by the CEO, and recognized \$12,500 (2021 \$Nil) in prepaid expenses;
- \$65,000 (2021 \$55,000 recorded as professional fees) in management fees to HWG Chartered Professional Accountants, a company which the CFO of the Company is a partner of;
- \$10,150 (2021 \$2,900) in rent expense (recorded in office expense) to the CEO of the Company for office space of which \$7,250 (2021 \$Nil) was recorded in accrued liabilities;
- \$Nil (2021 \$32,500) in marketing fees to Machai Capital Inc., a company controlled by a relative of the CEO;
- USD4,446(CAD5,829) (2021 USD9,600(CAD 11,712)) in Geological Consulting fees to Richard R. Kern, the Vice President of Exploration which was capitalized to exploration and evaluation asset.
- USD1,350 (CAD1,710) (2021 USD12,060 (CAD14,681)) in Geological Consulting fees to Richard S. Kern, a relative of the Vice President of Exploration which was capitalized to exploration and evaluation asset.
- \$Nil (2021 \$36,000) in consulting fees to Rodney Stevens, a director of the Company. The Company issued Nil (2021 105,000) shares valued at \$Nil (2021 \$37,800) to this director for these services, and \$Nil (2021 \$1,800) of GST.
- \$Nil (2021 \$27,071) in consulting fees to Stevens and Company, a company controlled by a director of the Company. The Company also issued Nil (2021 100,000) shares valued at \$Nil (2021 \$18,000) to this director for the settlement of \$Nil (2021 \$21,000) of accounts payable, resulting in a gain on settlement of debt of \$1,500.

During the nine months ended August 31, 2022 the Company recognized \$16,555 (2021 - \$148,934) for the vesting of options granted to related parties.

7. OFF-BALANCE SHEET ARRANGEMENTS

8. CRITICAL ACCOUNTING ESTIMATES

Critical accounting estimates are estimates and assumptions made by management that may result in a material adjustment to the carrying amount of assets and liabilities within the next financial period and include, but are not limited to, the following:

Recovery of deferred tax assets

The Company estimates the expected manner and timing of the realization or settlement of the carrying value of its assets and liabilities and applies the tax rates that are enacted or substantively enacted on the estimated dates of realization or settlement.

Environmental rehabilitation obligation

The Company recognizes statutory, contractual or other legal obligations related to the retirement of its exploration and evaluation assets and its tangible long-lived assets when such obligations are incurred, if a reasonable estimate of fair value can be made. These obligations are measured initially at fair value and the resulting costs are capitalized to the carrying value of the related asset. In subsequent periods, the liability is adjusted for any changes in the amount or timing and for the discounting of the underlying future cash flows. The capitalized asset retirement cost is amortized to operations over the life of the asset.

Share-based compensation

The fair value of stock options issued are subject to the limitations of the Black-Scholes Option Pricing Model that incorporates market data and involves uncertainty in estimates used by management in the assumptions. Because the Black-Scholes Option Pricing Model requires the input of highly subjective assumptions, including the volatility of share prices, changes in subjective input assumptions can materially affect the fair value estimate.

a) Critical accounting judgments

Information about critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements include, but are not limited to, the following:

- the assessment of the Company's ability to continue as a going concern and whether there are events or conditions that may give rise to significant uncertainty; and
- the classification / allocation of expenditures as exploration and evaluation expenditures or operating expenses.

9. SIGNIFICANT ACCOUNTING POLICIES

The Company's significant accounting policies are described in Note 3 of the audited financial statements for the year ended November 30, 2021, as found on SEDAR and www.sedar.com.

a) Recent accounting pronouncements

Certain other accounting pronouncements were issued but the Company anticipates that the application of these standards, amendments and interpretations in future periods will have no material impact on the results and financial position of the Company except for additional disclosures. The Company is assessing the impact of the new or revised IFRS standards on its financial position and financial performance.

10. FINANCIAL INSTRUMENTS AND RISK MANAGEMENT

The Company provides disclosures that enable users to evaluate (a) the significance of financial instruments for the entity's financial position and performance; and (b) the nature and extent of risks arising from financial instruments to which the entity is exposed during the period and at the date of the statement of financial position, and how the entity manages these risks.

The Company provides information about its financial instruments measured at fair value at one of three levels according to the relative reliability of the inputs used to estimate the fair value:

Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities;

Level 2 – inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices); and

Level 3 – inputs for the asset or liability that are not based on observable market data (unobservable inputs).

The Company's financial instruments consist of cash, receivables, and accounts. The carrying values of these financial instruments approximate their respective fair values due to the term of these instruments.

As at August 31, 2022, the fair value of cash held by the Company was based on level 1 inputs of the fair value hierarchy.

The Company's risk exposures and the impact on the Company's financial instruments are summarized below:

Credit risk

The Company's primary exposure to credit risk is its cash of \$570,094 at August 31, 2022. With cash on deposit with reputable financial institutions, it is management's opinion that the Company is not exposed to significant credit risks arising from the financial instruments.

Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due.

As at August 31, 2022, the Company had current liabilities totaling \$34,657 and cash of \$570,094 and is not exposed to significant liquidity risk at this time. However, since the Company is in the exploration stage, it will periodically have to raise funds to continue operations and intends to raise further financing through private placements.

Market risk

Market risk is the risk that changes in market prices such as commodity prices, foreign exchange rates and interest rates will affect the Company's income. The objective of market risk management is to manage and control market risk exposure within acceptable parameters. The Company does not use derivative instruments to reduce its insignificant exposure to market risks.
