As a result of net purchases of common shares of the Issuer (“**Common Shares**”) by Crescat in August, 2022, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 15%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 1,473,500 Common Shares in Crescat’s holdings representing an increase of approximately 2.66% on a non-diluted basis and, assuming that all of the share purchase warrants of the Issuer (“**Warrants**”) held by Crescat are exercised, an increase of approximately 2.63% on a partially diluted basis.

As at August 31, 2022, Crescat exercised control over 7,802,000 Common Shares, representing approximately 14.11% of the outstanding Common Shares, and 700,000 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 8,502,000 Common Shares representing approximately 15.18% of the issued Common Shares on a partially diluted basis as at August 31, 2022.

As at August 31, 2022, Crescat and the Joint Actors collectively exercised ownership and control over a total of 7,835,000 Common Shares (representing approximately 14.17% of the outstanding Common Shares) and 700,000 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 8,535,000 Common Shares representing approximately 15.24% of the outstanding Common Shares on a partially diluted basis as at August 31, 2022.
