As a result of net purchases of common shares of the Issuer ("**Common Shares**") acquired in January 2023, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 12.5%.

Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 10,957,500 Common Shares representing approximately 13.11% of the issued Common Shares on a partially diluted basis as at January 31, 2023.
