The Issuer’s issued and outstanding share capital increased. As a result of the foregoing, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 12.5%.

There has been a net increase of 840,000 common shares of the Issuer (“**Common Shares**”) and a decrease of 700,000 share purchase warrants of the Issuer; despite the foregoing, there has been a decrease of approximately 1.42% in Crescat’s securityholding percentage on a partially diluted basis due to an increase in the Issuer’s issued and outstanding share capital.

As at May 31, 2023, Crescat exercised control over 11,097,500 Common Shares, representing approximately 11.70% of the outstanding Common Shares.
