On April 25, 2023, Mr. Power disposed of 1,800,000 Shares of the Issuer pursuant to two private sale transactions. Following completion of the dispositions, Mr. Power now owns or has control or direction over, directly or indirectly, approximately 1.63% of the issued and outstanding Shares of the Issuer on an undiluted basis.

On April 25, 2023, Mr. Power disposed of 1,800,000 Shares of the Issuer at a price of approximately \$0.05556 per Share, for aggregate consideration of \$100,000.

Immediately prior to the dispositions, Mr. Power owned/controlled 1,972,433 Shares, or approximately 18.60% of the then issued and outstanding Shares of the Issuer, on an undiluted basis. As a result of the dispositions, Mr. Power now owns and/or controls 172,433 Shares, representing approximately 1.63% of the total issued and outstanding Shares of the Issuer. This represents an approximate 16.97% change in Mr. Power's ownership and/or control of Shares of the Issuer on an undiluted basis.
